## **BACKGROUND:**

On February 5, 2018 the Sapulpa Municipal Authority entered into an agreement with Tetra Tech for the design, bidding, construction administration, and resident project representation services associated with the construction of an additional one-way surge adjacent to the existing surge tank. Amendment No. 1 is for additional engineering services for a new 36" X 26" tee as requested by the City of Sapulpa and the City of Sand Springs.

The City of Sand Springs is apportioned 60% of the costs associated with the agreement for a total amount of \$19,000.00 and the City of Sapulpa is apportioned the remaining 40% resulting in an amount of \$7,600.00. For additional information regarding this item, please refer to the attachments.

# RESOLUTION NUMBER

A RESOLUTION APPROVING AMENDMENT NO. 1 TO AN ENGINEERING CONTRACT WITH TETRA TECH, INC., FOR SKIATOOK RAW WATER CONVEYANCE SYSTEM; AUTHORIZING BID OF THE PROJECT; AUTHORIZING AN AWARD OF CONTRACT IF WITHIN BUDGET; AUTHORIZING PAYMENT; AND AUTHORIZING THE SIGNATURE OF ALL RELATED DOCUMENTS.

WHEREAS, the City of Sapulpa has entered into an engineering contract for the construction of a second One Way Surge Tank in the Skiatook Raw Water Conveyance System, said tank to be construction on property to be acquired from the John Zink Foundation.

WHEREAS, the surge tank is an essential component to the water system in the area, and construction of a connection to the raw water line during the temporary shutdown of the raw line for other maintenance is necessary to ensure fewer additional disruptions of raw water to the City of Sapulpa and City of Sand Springs;

WHEREAS, approval of the additional contract services, bidding and award of bid are all necessary to avoid any unwarranted delays with the project;

WHEREAS, award of bid and associated alternates is necessary to construct this project;

WHEREAS, authorizing payments pursuant to the contracts is necessary to construct this project;

WHEREAS, approval of the documents associated with this project are in the best interest of the citizens of the City of Sapulpa;

THEREFORE, BE IT RESOLVED by the Trustees of the Sapulpa Municipal Authority as follows:

- 1. The Mayor and/or City Manager are authorized to sign an amended engineering services agreement with Tetra Tech at an additional amount not to exceed \$19,000. (Sand Springs \$11,400, Sapulpa \$7,600).
- 2. Bidding of the project is authorized upon completion of design.
- 3. The Mayor and/or City Manager are authorized to award a bid to the lowest and best bidder, if said bid is within the budgeted funds authorized for the project, and to execute an authorization to proceed.

- 4. All payments required pursuant to the contracts stated herein are authorized.
- 5. The Mayor and/or City Manager are authorized to sign all documents associated with the project.

#### AMENDMENT NO. 1 TO AGREEMENT FOR ENGINEERING SERVICES BETWEEN SAPULPA MUNICIPAL AUTHORITY AND SAND SPRINGS MUNICIPAL AUTHORITY, OWNERS AND TETRA TECH, INC., ENGINEER FOR SKIATOOK RAW WATER CONVEYANCE DYDTEM ONE WAY SURGE TANK

THIS AMENDMENT NO. 1, made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2018, by and between Sapulpa Municipal Authority and Sand Springs Municipal Authority, hereinafter referred to as Owners, and Tetra Tech, Inc., hereinafter referred to as Engineer, said parties being the same who executed the original Agreement for Engineering Services, dated the 5<sup>th</sup> day of February 2018.

#### WITNESSETH:

WHEREAS, Owner requires certain engineering services outside the Scope of Services stated in Attachment A of the original Agreement; and

WHEREAS, Engineer is prepared to provide said additional services;

NOW THEREFORE, Engineer and Owners agree to amend certain items of the original Agreement as follows:

#### Item No. 1

Add Item B to Attachment A, Scope of Services to read as follows:

B. Bidding Phase. Owners desire to construct a portion of the original project and requested the Engineer to provide bidding services. The portion of the project included in this Amendment No. 1 is to cut in a new 36" x 24" tee in the existing 36-inch line and provide a valve and blind flange for future connection to the new one-way surge tank (designed under the original contract). Engineer will prepare a separate and standalone bidding and construction documents from the original scope to include all work required to construct the 36"x24" tee.

The scope for the bidding phase will include the following:

- 1. Advertisement. Coordinate the bid advertisement with the Owner's staff.
- 2. Pre-Bid Conference. Conduct a pre-bid conference for the Project to address critical Project matters with potential bidders.
- 3. Addenda. Prepare and issue all addenda determined necessary throughout the bidding phase.
- 4. Bid Opening. Attend and assist the Owner at the bid opening.
- 5. Bid Tabulations and Review. Review all bids, prepare a bid tabulation and investigate the qualifications of the apparent low bidder.
- 6. Contract Award. Prepare a recommendation for award of the construction contract based on the bid tabulation and investigation of the apparent low bidder.
- 7. Contract Preparation. Coordinate the preparation and execution of construction contract documents.

#### <u>Item No. 2</u>

Add Item C to Attachment A, Scope of Services to read as follows:

C. Construction Administration. Owners desire to construct a portion of the original project as described in Item 1 of this Amendment No.1., and requested the Engineer to provide Construction Phase services. The scope for the construction phase will include the following:

- 1. Pre-Construction Conference. Conduct the pre-construction conference and issue the necessary memorandum. The conference shall initialize the construction administration services on each individual Project. The duration of the construction phase is <u>anticipated to be 4 calendar months</u>.
- 2. Construction Progress Meetings. All progress and coordination meetings necessary during the Project shall be coordinated by the Engineer. Chairing of said meetings shall be as appropriate to the meeting being held. In general, progress meetings shall be conducted a minimum of monthly during the Project and as often as weekly during critical phases of any work.
- 3. Submittal Review. Engineer shall review Contractor's material submittals, equipment shop drawings, and material test certifications for compliance with the approved plans and specifications.
- 4. Pay Estimates. Prepare and process construction pay estimates and make recommendations for each based upon details provided by the Resident Project Representatives.
- 5. Contractor's Schedule. Review and make comments on the contractor's proposed construction schedules. Monitor the progress of each contractor relative to the approved schedule throughout the construction Project and report problems, concerns, and proposed remedies to Owner.
- 6. Contractor's Claims. Evaluate to present options and opinions for consideration by the Owner on claims submitted by the contractors.
- 7. Change Orders. Evaluate and prepare change orders necessary for the Project and make recommendation to Owner.
- Resident Project Representative(s). Supervise the Resident Project Representative(s). Reports of the daily construction activities shall be prepared by the Resident Project Representative.
- 9. Clarifications. Engineer shall provide clarifications and decisions in accordance with the contract documents on question regarding the work or intent of the project requirements.
- 10. Visual Documentation. Compile pre-construction and construction photographic and video documentation of the Project.
- 11. Pre-Final Inspections. Conduct pre-final inspections with the contractor and prepare the necessary punch lists for distribution.
- 12. Final Inspections. Conduct the final inspections after completion of the punch lists by the contractors.
- 13. Acceptance. Prior to final acceptance of the project, Engineer shall review the contractual requirements of the Contractor and, only upon receipt and satisfaction of those requirements, recommend acceptance of the project by the Owner. Review shall include acceptable performance tests of equipment and sequencing required by the construction contract.
- 14. Record Drawings. Update electronic files (ACAD) of construction drawings to reflect the "asconstructed" configuration of the Project. Submit to Owner 1 set of reproducible record drawings at completion of the Project

#### <u>Item No. 3</u>

Add Item D to Attachment A, Scope of Services to read as follows:

D. Resident Project Representation. Owners desire to construct a portion of the original project as described in Item 1 of this Amendment No.1, and requested the Engineer to provide Resident Project Representation Services. The scope for the construction phase will include the following:

Engineer shall provide PART-TIME resident project representation services. The basic scope is based on a 4-calendar-month construction period. A maximum of 40-hours of on-site representation is included in the basic scope.

#### <u>Item No. 4</u>

Modify Item I.A. of Attachment B of the original agreement as follows:

For basic engineering services performed under Article 3, the Owners will pay the Engineer at the hourly rates, plus burdened expenses, set forth in Engineer's Rate Schedule. The rates include

all costs including overhead and profit. Total Maximum billing shall not exceed for each phase as follows:

- a. Design Phase. The total billing shall not exceed \$44,700.00. (No change)
- b. Bidding Phase. The total billing shall not exceed \$6,500.00. (An increase of \$6,500)
- c. Construction Phase. The total billing shall not exceed 12,500.00. (An increase of \$12,500)

Total fee for all phases of Basic Engineering Services shall not exceed \$63,700.00. (An increase of \$19,000).
