#### **SUBJECT:**

Discuss and consider a Resolution of the City of Sapulpa, Oklahoma, amending the FY 2018-2019 Grants and Aid Fund annual budget by increasing revenues in the amount of \$72,550.00 and appropriations in the amount of \$55,627.00 to recognize donations and grant revenue from the Federal Emergency Management Agency (FEMA) to be used for training.

#### **BACKGROUND:**

City Council previously accepted a grant from FEMA in the total amount of \$293,191.00 with a required match of \$29,319.00 for a total amount of \$322,510.00. These funds are to be used for rescue and hazmat training including the cost of callback pay required. A previous resolution appropriated funds for the rescue training but the funds for the hazmat training have not been appropriated. At this time the costs of the hazmat training has been estimated at \$55,627.00 with FEMA funding of \$50,064.00.

The city has received donations in the amount of \$25,627.00 for both the rescue and hazmat training that has not been recognized. At this time the donations and the grant funds should be recognized and appropriated for the purpose of hazmat training.

**WHEREAS,** the City of Sapulpa, Oklahoma received a grant award from FEMA in the total amount of \$293,191.00 with a required match of \$29,319.00 for a total cost of \$322,510.00; and

**WHEREAS**, the funds will be used for rescue and hazmat training including the costs of callback pay required; and

WHEREAS, the funds for the rescue training have been previously appropriated; and

**WHEREAS,** at this time the costs of the hazmat training have been estimated at \$55,627.00 with the FEMA share of \$50,064.00; and

**WHEREAS**, the City has received donations in the amount of \$22,486.00 for both the rescue and hazmat training,
