According to City Planner Rachel Clyne, the application for rezoning complies with the Sapulpa Comprehensive Plan Future Land Use Map, and city staff recommends the approval of the zoning change. The Sapulpa Metropolitan Area Planning Commission considered the rezoning request at their meeting of December 13, 2016, and voted 7 - 0 to recommend to the council the denial of said application. Citizens speaking in opposition to the rezoning request at the SMAPC meeting expressed concerns about tree removal from the property, curb parking, danger from tenants, and decreased property values.

Mr. Greg Hurst, applicant, told the council the owner intends to build four duplexes on the property. Each home will have an estimated property value of \$230,000, which is more than the existing homes in the area are currently valued. Also, there are no city restrictions on tree removal by property owners, and curb parking is permitted in front of a resident unless marked by no parking.
